Inclusion of promotions, product or service claims, prices, etc., will be rejected and similar information will be subject to review by the Chapter for exclusion. No claim for endorsements by ASIS International or Oklahoma City Chapter # 58 can be made within logo or contact information. Appearance and set-up will be consistent with the agreement in place between Wheat Communications Website Designers and the Oklahoma City Chapter of ASIS International.

Sponsorship Fee: The Sponsor agrees to the fee amount payable in advance as stated below and as set by the Chapter from time to time. Payment may be made by Check payable to the ASIS Chapter #58.
